

FOCUS ON STITCH

VIRTUAL EMBROIDERY EXHIBITION ENTRY FORM

All work submitted for ANZEG's Junior Virtual Embroidery Exhibition 2020 should 'Focus on Stitch', whether traditional or contemporary, hand or machine embroidery, lace or beadwork.

Young Persons' theme:

Imagination

Dreams, the view ahead



1. Not selected. Open to all young embroiderers, not just Guild members.
2. Three sections:
 - a. Individual section open to any young person 12 years and under as at October 1, 2020;
 - b. Individual section open to any young person 13 to 18 years as at October 1, 2020;
 - c. Group section open to a group of young persons aged under 18 years as at October 1, 2020;
3. They should be imaginative in design, stitching and colour.

Conditions of Entry

1. All entries must be completed within the two years prior to October 2020. Entries are not subject to selection.
2. Original work is preferred. Kitsets are not allowed but you can adapt someone else's design for your own embroidery as long as you tell us who the original designer is (for copyright purposes) and the designs name (if known).
3. All work must have a high percentage of stitch content, which may be by hand or free motion machine. Lace and beadwork will be accepted.
4. Entries must not have been previously exhibited in any other exhibition or public display of work in New Zealand.
5. The judges' decision will be final and no correspondence will be entered into. No supporting documentation will be accepted.
6. All entries intending to be hung must have a secure means of hanging. All works must have a label attached to the back of the work indicating the right way up, the name of the artist and the title of the work.
7. No glass please. Glass is a safety hazard as it can break in transit. It is also difficult to photograph.
8. When sending your work, please ensure that it is well packaged so that it arrives in display condition.
9. Insurance of entries is the sole responsibility of the exhibitor.
10. The judging will take place shortly after the closing date. Works will be returned at the conclusion of the exhibition.
11. Entry fees must be paid before Friday September 25, 2020 and are non-refundable.

Entry Fees

The individual entry fee for 12 & Under and 13-18 Years is \$5 per piece entered (up to 3 entries per child).

The Group entry fee is \$10 per piece (1 per group).
